
Marleen van Rijswick received Schilthuispenning



Prof. mr. Van Rijswick was handed over the Schilthuispenning on 10 February by Minister Schultz van Haegen (Infrastructure and Environment) for her achievements in the field of water law and water management. This prize is being awarded once or twice annually to an individual or to an organization for achievements in – and the development of – the field of water law.



JACANA Project in South Africa in cooperation with Rotary Bilt-hoven



In June 2016, Marleen van Rijswick and Anoeska Buijze will accompany six students to South-Africa for the JACANA Project. The project supports the Inkomati-Usuthu Catment Management Agency in order to improve the strategic and operational water management. By exchanging views and ideas with various stakeholders, the students aim to set up a reciprocal learning process. In doing so, the focus will be on vulnerable groups and to include their interests in the water management (by stressing on inclusiveness and participation).

Tineke Lambooy and Aikaterini Argyrou participated at a work conference organised by Social Enterprises NL

The work conference with the title 'The social enterprise on the way to the Civil Code' (De sociale onderneming op weg naar het Burgerlijk Wetboek) was held in The Hague at the facilities of the Sociaal-Economische Raad (SER) on the 14th of January 2016. The working conference was organised by Social Enterprises NL with the objective to discuss in detail with a broad group of stakeholders the vision of Social Enterprises NL for a new legal regime applicable to social enterprises in the Netherlands.

At the conference Tineke Lambooy gave a keynote speech regarding the 'International perspective on the legal position of social enterprises' (Internationaal perspectief op de juridische positie van de sociale onderneming). Both Tineke Lambooy and Aikaterini Argyrou participated in an intensive dialogue organised in discussion tables regarding the role of stakeholders in the governance of social enterprises. A colleague from Edinburgh University, David Cabrelli, was invited by Aikaterini Argyrou to share the insights gained in Scotland with the functioning of the Community Interest Company.

Future Deltas

'An empirical investigation of supportive legal frameworks for social enterprises in Belgium: A cross-sectoral comparison of case studies for social enterprises from the social housing, finance and energy sector perspective', in V. Mauerhofer, (Ed.) Legal Aspects of Sustainable Development: horizontal and sectorial policy issues, Springer, 2016.

Abstract

This study aims to investigate how the existing legal framework for social enterprises in Belgium affects the activity of social enterprises in the social housing, finance and energy sector. The article focuses on the examination of the legal factor of governance as well as the decision-making power of stakeholders in one particular type of social enterprises, the so-called company with a social purpose, 'Vennootschap met Sociaal Oogmerk' (VSO). The authors conducted three case studies. They examined three social enterprises which are active in three different sectors in Belgium i.e. the energy, finance and housing sector. By comparing three case studies, this article aims to generate a cross-sectoral theoretical analysis regarding the practical application of the legal factor of governance in the Belgian social enterprises as well as a comprehensive understanding of the involvement of different stakeholders in the social enterprises governance in three different sectors. The cross-sectoral analysis elaborated on the implementation of the legal provisions with respect to the governance of social enterprises as well as on the participation of various types of stakeholders in the decision-making process in every sector. Useful conclusions were drawn for the improvement of the legal framework of social enterprises in Belgium as well as for the improvement of the social enterprises functioning.

Organisation and chairing the CSR workshop of the Ius Commune Conference 2015 in Leuven with the topic 'Tailor-made Legal Frameworks for Social Enterprises'

Tineke Lambooy and Aikaterini Argyrou organised a session on Corporate Social Responsibility at the annual Ius Commune Conference 2015 that took place in Leuven on the 27th November 2015. The workshop with the title 'Tailor-made Legal Frameworks for Social Enterprises' combined various perspectives: sustainability, innovation and corporate law.

The purpose of the CSR workshop was to build awareness and a comprehensive understanding of tailor-made legal models for social enterprises in Europe. Tineke Lambooy and Robert Helder chaired the session. Various presenters provided legal, academic and practical insights into the concept of social enterprises as well as knowledge regarding the implementation of tailor-made legislation on a national level. Stijn De Jonge, a colleague of the university of Leuven and also a social entrepreneur commenced with a keynote speech. The topic regarded the legal structure of CORE CVBA-SO, a social enterprise which is located in

Leuven, in which he plays an important role, which is stimulating innovation in the area of sustainability, and in which social enterprise students of Leuven university hold shares.

Aikaterini Argyrou presented part of her PhD research at the workshop explaining - with the assistance of Guus Kruseman (LLM UU student) - the legal framework for the Vennootschap met Sociaal Oogmerk (VSO) (Company with Social Purpose) in Belgium as well as the implementation of the Belgium VSO legislation in the organizational model of social enterprises in three different sectors, i.e. the energy sector, the finance sector, and the social housing sector (on the basis of 3 case studies). The discussion generated a forum for legal researchers to exchange ideas and knowledge on the topic of legislation applicable to social enterprises, and will conclude with formulating new research questions.

Congres 'Waterbeheer in de Lage Landen' (in Dutch)

Implementatie van de Kaderrichtlijn Water: alles in goede toestand?

Vanuit de bestaande samenwerking tussen de Universiteit Gent, de Vlaamse Vereniging voor Omgevingsrecht en de Vereniging voor Milieurecht organiseerde het Utrecht Centre for Water, Oceans and Sustainability Law (UCWOSL) op 4 december 2015 het congres 'Waterbeheer in de Lage Landen'. Onder leiding van dagvoorzitters Marleen van Rijswick (UCWOSL, Universiteit Utrecht) en Frank Maes (Universiteit Gent) werd de Europese Kaderrichtlijn Water (KRW) vanuit verschillende juridische en bestuurlijke oogpunten besproken.

Het 15-jarige bestaan van de Europese Kaderrichtlijn Water, de Wezer-uitspraak en het naderende punt van afronding van de tweede ronde beheerplannen gaven genoeg aanleiding om de Kaderrichtlijn water grondig onder de loep te nemen. Daarnaast diende in beginsel eind 2015 aan alle milieudoelstellingen te zijn voldaan, tenzij lidstaten een terecht beroep op één van de uitzonderingsbepalingen konden doen. Door middel van verschillende workshops onder voorzitterschap van Barbara Beijen, Daan Korsse en Petra Lindhout (alle drie verbonden aan de Universiteit Utrecht) en Jacqueline Zijlmans (Rijkswaterstaat Corporatie Dienst) werden de deelnemers bijgespikkeld op het gebied van de implementatie van de richtlijn en was er ruimte voor discussie.

Het congres vond plaats in een gerenoveerd historisch pand van de Universiteit Utrecht, dat speciaal voor dit evenement zijn deuren opende nog voor de officiële ingebruikname. Het feestelijke karakter van de bijeenkomst kwam naar voren tijdens de lunch en borrel, waarbij de deelnemers en sprekers volop de gelegenheid hadden om bij te praten en te netwerken. De workshops en plenaire sessies brachten felle discussies naar voren over de uitleg van de Kaderrichtlijn water maar ook een positieve zoektocht naar hoe het wél zou kunnen en moeten binnen de Nederlandse wensen en verhoudingen. Verder vormden de workshops een mooi platform voor uitwisseling van informatie en *best practices* tussen de Nederlandse en Belgische collega's.
