

# SIM to host annual Association of Human Rights Insitutes Conference



On 2-3 September 2016, the Netherlands Institute of Human Rights is honoured to host the 2016 Association of Human Rights Institutes Conference. The conference is entitled "50 Years of the Two UN Human Rights Covenants: Legacies and Prospects" and will be attended by an impressive range of human rights scholars from

around the world. There will be nearly 100 speakers, a number of them SIM researchers, presenting on six major themes: (i) the indivisibility and interactions of norms and regimes; (ii) citizenship, migrants and refugees; (iii) non-state actors and human rights; (iv) the EU and human rights; (v) the global economy and human rights; and (vi) new avenues in human rights research. ### (i) International Human Rights Law: An Introduction

This one-week introduction course between 11 and 15 July focuses on the major features of international human rights law. It begins by examining the philosophical and political bases of human rights and then explores human rights documents and mechanisms for the promotion and protection of human rights at the international and regional levels. Human rights-based approaches for analyzing conflict and attempts to promote peace and justice will also be explored. Through lectures, interactive working groups, expert panels and excursion(s), participants will gain an understanding of the various elements - and their interplay - involved in this field. ### (ii) International Law from a Gender Perspective

This interactive one-week course between 18 and 22 July will look at law from a gender perspective, encompassing cis, gay, trans and intersex perspectives. The focus is primarily on human rights but will cut across other areas of international law, such as refugee law. Through lectures, excursions, and group assignments, topical issues will be explored and analysed, linking theory and practice. The Shelter City Initiative offers human rights defenders a possibility for rest and respite by letting them escape temporarily from a threatening situation. The program's objective is to offer the human rights defenders a shelter for three months, during which she/he will rest, build up capacity and extend his/her network. SIM is able to help human rights defenders participating in this scheme by sharing hunman rights resources and giving them access to relevant human rights education.

### Remembrance and Liberation Day

Each year the Netherlands commemorates its war victims on the fourth of May. This year, Utrecht University organized a symposium preceding the formal commemoration ceremony. The symposium centered on Free Speech. Amongst

the speakers were a refugee from Turkey, a sociologist, and a literature scholar. Professor Antoine Buyse addressed the issue from a human rights

perspective, going into misconceptions about the freedom of expression. The next day, 5 May, on which the liberation of the Netherlands at the end of World War II is annually celebrated, a documentary was aired on local Utrecht television on current conceptions of freedom, in which Antoine was also interviewed. 
### Workshop on Vulnerability and Human **Rights Law**

On 29 February 2016, Alexandra Timmer, Assistant Professor at SIM, organized an informal expert workshop on the concept of vulnerability in human rights law. Researchers from Belgium, the Netherlands, Spain and Switzerland participated. The concept of vulnerability has gained momentum in human rights law and literature. During the workshop, the participants discussed how vulnerability relates to human rights, and how using this concept in human rights-related research brings both potential and challenges.

cialists, and representatives of social organizations in Mexico and elsewhere that are active in the fields of impunity, justice and truth finding. The objective of the seminar was to strengthen the ties between analysts and activists, and to jointly develop a perspective that puts at the centre people's experiences and solutions. ### 57th Annual Convention of the International Studies **Association**

Daphina Misiedjan, PhD candidate at Utrecht University, spoke at the symposium 'New Frontiers in Global Environmental Constitutionalism: Implementing Human and Environmental Rights in Global Context', held at North-West University, Potchefstroom, South Africa from 12-14 April 2016. Widener University Delaware Law School (USA) and the UN Special Rapporteur on Human Rights and the Environment, Professor John Knox, co-hosted the symposium, which was sponsored by the Konrad Adenauer Stiftung (KAS). Daphina presented her paper on the ten building blocks for sustainable access to water for domestic purposes of vulnerable groups. Presentations given at this symposium can be found here. ### Conference on Human Dignity and **Human Rights**

On 29 May dr. Brianne McGonigle, Associate Professor at SIM, Leyh spoke at a three-day Conference organized by the Ethics Institute of Utrecht University entitled 'The Future of Human Rights: History, Norms & Institutions' which formed part of the NWO Project 'Human Dignity as the Foundation of Human Rights'. Brianne spoke on the use of human dignity by regulatory bodies in the context of gender stereotyping and the media.

### Armed groups and the ICC

On the 23rd of March, Katharine Fortin gave a lecture at the International Criminal Court on the accountability of armed groups under international human rights law. She was invited by the Prosecutor of the ICC. Presenting to staff from all organs of the Court, Katharine's lecture looked particularly at the case law on crimes against humanity and its relevance to determining when armed groups are bound by human rights law.

### Lecture for the Jus Commune Research School

On 29 April, Dr. Brianne McGonigle Leyh, Associate Professor at SIM, gave a seminar on 'American Common Law, Comparative Methodologies' for the lus Commune Research School. The lus Commune Re-

search School is a cooperation between the law schools of Maastricht University, Leuven University, Utrecht University, and the University of Amsterdam.

On 26 May, SIM-fellow Professor Janneke Gerards gave a presentation at an expert meeting on the contribution of national constitutions to the protection of human rights, entitled 'The Impossibility of Constitutional Change in the Netherlands, and the ECHR as a Substitute Constitution'. The expert meeting was held at the University of Saint-Louis, Brussels, Belgium.

### Expert meeting on nation- Expert roundtable at the Hague Institute for Global Justice

On 8 June Aurélie Roche-Mair, organized a roundtable on 'Trials in Absentia in International Criminal Justice'. The event was hosted at the Haque Institute for Global Justice and welcomed judges and

practitioners from the international criminal courts operating in The Hague. Dr. Brianne McGonigle-Leyh, Associate Professor at SIM, presented on the approach of the Human Rights Committee and the European Court of Human Rights.



### **Human Rights Dialogue**

The Human Rights Dialogue is an initiative by Cordaid, the Dutch Committee of Jurists, The Netherlands Institute of Human Rights (SIM) and Dietz, Dröge en Van Loo. It is held twice a year and provides a platform for the discussion of human rights related themes for Dutch politicians.

As part of the human rights dialogue, in May 2016 a group of Dutch local politicians from various political party and cultural backgrounds visited London and York to study human rights policy practices. The group met over 40 experts in over 25 meetings on concrete solutions to matters such as ethnic profiling, racism and football, human rights education, antisemitism, accessibility for disabled people, mental health, children's rights and the use of taser guns, and islamophobia. City councilors returned to the Netherlands with many ideas for policy initiatives to contribute to the promotion and protection of human rights.

### Washington College of Law Summer Program in The Hague

On 9 June 2016, Dr. Brianne McGonigle-Leyh, Associate Professor at SIM, spoke at a career and networking panel for American University's Washington College of Law Summer Program in The Haque, hosted at the T.M.A. Asser Institute.

### Public debate on equality

On 19 April, SIM-fellow Professor Janneke Gerards participated in a public debate meeting in Amsterdam on 'The Commons and the Principle of Equality', organised by the New Amsterdam Academy (KNAW and Pakhuis de Zwijger).

### UCIS Lecture with Lieutenant General Leo Beulen

On 11 May 2016, Katharine Fortin chaired a UCIS lecture given by Lieutenant General Leo Beulen on international military cooperation and military operations. On 24 March 2016, Lieutenant General Beulen was appointed as the Commander of the Royal Netherlands Army.

On 6 June, SIM-fellow Professor Janneke Gerards participated in a conference held by the Europäische Rechtsakademie (ERA) in Trier, Germany, entitled 'Current reflections on EU Anti-Discrimination Law'. Janneke gave

# Liesbeth Enneking inaugural lecture at the University of Leuven

SIM-fellow Dr. Liesbeth Enneking holds the yearly rotating chair of the Journal of Private Law from 2015 to 2016. On 13 May 2016 she gave the inaugural lecture at the University of Leuven entitled 'People, Planet, ... Procedure? – About the care obligations of companies under international corporate so-

### Article 1 lecture

On 1 April SIM-fellow Professor Janneke Gerards held the 'Article 1' lecture, in which she addressed the question of whether Article 1 of the Dutch Constitution (which prohibits discrimination on a number of grounds) should be amended. Janneke argued that a simple prohibition of discrimination (without mentioning any specific grounds) would be desirable. The lecture will be published in the Netherlands Journal for Human Rights (Nederlands Tijdschrift voor Mensenrechten / NJCM Bulletin) in August/September.

**ECHR and EU Training for Judges** 

Both in March and May, Antoine Buyse gave full-day trainings on the European Convention on Human Rights to judges and judges in training, in Rotterdam and Utrecht respectively. In addition, on 23 May, together with Mirjam de Mol, SIM-fellow Professor Janneke Gerards provided a training course to trainee judges on the EU Charter of Fundamental Rights. The trainings were organized by the Dutch Training and Study Centre for the Judiciary.



# FRAME project: General Assembly and presentation at EU human rights working party

The past few months have been busy in the <u>FRAME project</u>. Besides submitting the final reports, Dr. Lorena Sosa and Dr. Alexandra Timmer had the honor to present findings from the project to the Working Party on Human Rights (COHOM) of the EU External Action Service. In the context of the Netherlands' Presidency of the EU, the COHOM held an informal meeting in Amsterdam in April 2016. Lorena and Alexandra gave a presentation entitled 'Human rights, democracy and the rule of law: engaging with contested conceptualizations'. Together with Jenny Goldschmidt, they also attended the annual FRAME General Assembly in Leuven and Brussels on 6 and 7 June. During the General Assembly, FRAME-partners from 19 universities and research institutions convened to discuss their ongoing research and exchange views on EU human rights with key policy makers.



are thieves', 'women are responsible for childcare', and 'people with a mental disability are incapable of forming political opinions'. Increasingly, human rights monitoring bodies – including the European and Inter-American human rights courts, the Committee on the Elimination of Discrimination against Women, and the Committee on the Elimination of Racial Discrimination – voice concerns about stereotyping and warn States not to enforce harmful stereotypes. It appears that human rights bodies are starting to realize what social psychologists discovered a long time ago: that stereotypes underlie inequality and discrimination. However, despite their relevance and their legal momentum, stereotypes have so far received little attention from human rights law scholars. This volume is the first one to broadly analyze stereotypes as a human rights issue. The scope of the book includes different stereotyping-grounds – such as race, gender, and disability. Moreover, this book examines stereotyping approaches across a broad range of supranational human rights monitoring bodies, including the United Nations human rights treaty system as well as the regional systems that are most developewhen it comes to addressing stereotypes: the Council of Europe and the Inter-American System.

On 29 June, The Hague Institute and the University College Roosevelt hosted the book launch of *Global Urban Justice: The Rise of Human Rights Cities*, edited by SIM-fellow Professor Barbara Oomen together with Martha F. Davis of Northeastern University, Boston, and Michele Grigolo of Nottingham Trent University, UK. The book brings togeth-



er academics and practitioners at the forefront of human rights cities and the "right to the city" movement to critically discuss their history and also the potential that human rights cities hold for global urban justice.

Antoine Buyse and Oddný Mjöll Arnardóttir (eds.) – Shifting Centres of Gravity in Human Rights Protection. Rethinking Relations between the ECHR, EU, and National Legal Orders (Routledge 2016)

The protection of human rights in Europe is currently at a crossroads. There are competing processes which push and pull the centre of gravity of this protection between the

ECHR system in Strasbourg, the EU system in Luxemburg and Brussels, and the national protection of human rights. This book brings together researchers from the fields of international human rights law, EU law and constitutional law to reflect on the tug-of-war over the positioning of the centre of gravity of human rights protection in Europe.



### **European Equality Law Network reports**

Alexandra Timmer, Assistant Professor at SIM, is acting-coordinator of gender equality law at the EELN. Together with Linda Senden, Professor of EU law at Utrecht University, she has written a report for the EELN entitled 'A comparative analysis of gender equality law in Europe — 2015'. In addition, two thematic reports related to gender equality have now been published: 'Legal implications of EU accession to the Istanbul Convention', written by Kevät Nousiainen and Christine Chinkin; and 'Measures to address the challenges of work-life balance in the EU Member States, Iceland, Liechtenstein and Norway', written by Aileen McColgan. ### Publication of a report on the duties of care of Dutch companies

At the request of the Dutch ministries of Security & Justice and of Foreign Affairs, SIM-fellow Dr. Liesbeth Enneking has together with a group of researchers of the Utrecht Centre for Accountability and Liability Law (UCALL) published a re-

port on the duties of care of Dutch business enterprises with respect to international corporate social responsibility, entitled *Zorgplichten van Nederlandse ondernemingen inzake internationaal maatschappelijk verantwoord ondernemen*. This report explores the ways in which and to what extent a duty of care of Dutch corporations with regard to international corporate social responsibility has been laid down or applied in Dutch legislation and/or case law, and to what extent the present state of affairs relates to both the UN Guiding Principles and the state of affairs in neighbouring countries.
