

Checklist Entry Requirements

Social, Health and Organisational Psychology

This form is NOT required for students with a Bachelor:

- Psychology, at a Dutch research University
- Interdisciplinary Social Science, Pedagogical Sciences and Sociology at Utrecht University
- Liberal Arts and Sciences (LAS) from Utrecht University, with a specialization in Social, Health and Organisational Psychology

For all other students, this form is mandatory.

In the scheme below you have to show to the Admissions Committee how you have acquired each competency. List all relevant academic courses per entry requirement or other relevant academic experiences (such as internships, summer courses, thesis or extra-curricular research). For all courses you list, you need to hand in supporting documents that proof:

- a) You have passed a course (or will take the courses if not yet passed).
- b) The course content.

You can upload these documents via the application process in Osiris Online Application. The Admissions Committee accepts the following supporting documents as proof:

- Official transcript.
- A list of courses yet to be completed (official or written yourself).
- a digital copy of your thesis or similar research report (or research plan if you have not written your thesis yet).
- Official course syllabi in English or Dutch (online or offline), including information on course content, learning goals, weekly schedule, etc.

1. Psychological theories

You have basic academic knowledge of the key sub-areas of psychology such as Experimental Psychology, Developmental Psychology, Clinical/Health Psychology, and Social/Organisational Psychology).

You meet this competency when you have obtained at least 30 EC of basic academic knowledge of the key fields of Psychology.

I meet this requirement via the following academic courses:

2. Specific knowledge regarding Master

You have advanced academic knowledge of psychology (i.e. Bachelor exit level), preferably in the field of: Social Psychology (including social cognition and attitudes, interpersonal processes, group processes) and/or Health Psychology (including self-regulation, motivation and emotion, health psychology) and/or Work and Organisational Psychology (including work psychology, organisational psychology, Human Resource Management).

You meet this competency when you have obtained advanced academic psychology courses, preferably in the field of the Master's track of your choice (at least 20 EC).

I meet this requirement via the following academic courses:

If you have advanced knowledge in psychology but outside of your track choice, you will be required to enhance your knowledge by self-study. The Admissions Committee will provide a literature list if accepted.

3. Methods and statistics & Research report

You are able to design and conduct quantitative scientific research in the field of Social, Health or Organisational Psychology (under supervision). You can use multivariate statistics to analyse your results, and you can report and reflect on your research in a critical and constructive manner.

You meet this *requirement* when:

- a)** You have successfully completed a basic course in introductory statistics including topics such as: univariate descriptive statistics, correlation, univariate regression, one-way analysis of variance, and a basic course in the methodology of behavioural and/or social science research (experimentation, surveys, observational studies)

I meet this requirement via...

- b)** You have knowledge of, and experience, with multivariate analyses such as multiple regression or multivariate analysis of variance (MANOVA).

I meet this requirement via...

- c)** You have hands-on experience with a statistical programme, such as SPSS

I meet this requirement via...

- d)** You can show proof of a *quantitative* Bachelor's thesis or quantitative research report (at least 10 EC) in which you have completed the entire empirical cycle, including quantitative analyses, with a subject in the field of Social or Behavioural Sciences. The thesis or report should demonstrate that you can report and reflect on your research in a critical and constructive manner.

I meet this requirement via...

4. Communication techniques

You can communicate in a clear and effective manner, both verbally and in written form, tailored to the other person(s) and the specific setting/situation.

You can show proof that you possess professional verbal and writing communication skills (for instance acquired during your education, or during relevant extracurricular activities).

The Admissions Committee will take into account your complete application file (including motivation letter and CV) to determine your communication techniques.

Please realise that the Admissions Committee is unfamiliar with your specific curriculum. Via course syllabi the content of a course can be verified. When the Admissions Committee is unable to verify the course content or experience, it will not be taken into account in the assessment of your application file.
